SET UP: Thursday noon-6pm; Friday 8am-noon

2 Vendor Passes only. Others can be purchased at the gate.

The exhibitor agrees to exhibit/sell only those items approved by the Festival Committee as hereinafter specified on this contract.

Exhibitors must pay all sales taxes due from the sale of items.

Remove all items, debris, etc brought in for the purpose of constructing a display by noon on Monday immediately following the event.

NO parking campers, camping tents, vehicles, etc.. in the vendor area.

Overnight security will be provided on Thursday, Friday, and Saturday night.

Vehicles are allowed to unload, then must be removed before set-up.

Exhibits must stay within their designated booth space.

Tables, pop-up tents, stakes, etc.. are not available so please bring your own.

You may bring a cooler with you. No glass containers allowed.

PLEASE do not dismantle your display until 4pm on Sunday.

If you do, you may not have a spot for the following year.

No cars will be allowed in the vendor area until 4:30pm on Sunday. Please take down your display then go get your car. This helps stop congestion and protects everyone.

This agreement is subject to change and cancellation, at the sole discretion of the Chamber, for proven, legitimate conditions beyond the control of either party. Such as accidents, riots, strikes, epidemics, and acts of God. Or failure to meet the conditions specified above by the Exhibitor, on a case to case review.

Vendor agrees to indemnify the Chamber for any claims/suits by third parties for activities/duties of the vendor.

Complete and send the contract with your signature and address. Your application/contract will be reviewed and, if accepted, a fully executed copy will be returned to you at the address you provide. If not accepted, an explanation and your check will be returned to you.
